Working together to accelerate development is one of the goals of SAARC nations. SAARC also aim for strengthening cooperation with other developing nations and also to cooperate with international and regional organizations with same kind of goals and purposes. Out of the total eight nations, India is playing a significant role in promotion of trade and economic cooperation with SAARC nations. The main aim of this study is to examine the foreign trade of India with the SAARC nations followed by recent Trends of export-Import under the BJP led NDA government during 2014-2024 (current decade) with SAARC nations. India's export import trend with SAARC countries shows increasing pattern with holding a noteworthy trade surplus with the most members nations such as Bangladesh, Nepal, Sri-Lanka and Pakistan. The study is tried to elaborate how An Export and Import of India have been increasing and changing over a period of time. Indian economy is also considered as a stable and dynamic within the SAARC region with estimated growth rate approximately of 7 percent.

India's trade with SAARC nations has seen a gradual increase, though the overall volume remains limited compared to its global trade. According to data from the Department of Commerce, Government of India, India's exports to SAARC countries have shown an upward trend over the years. For instance, exports to Bangladesh and Nepal have been particularly robust, driven by demand for Indian goods and India's role in supplying essential commodities.

However, trade with Pakistan has been inconsistent, influenced by political tensions. Periods of diplomatic strain have led to fluctuations in trade volumes, with notable declines during times of heightened conflict.

The data presents strong evidence of the advantages of expanding intraregional trade, including the transfer of appropriate production technology, comparative advantage, complementarities, wider markets, and greater exploitation of production capacity. Furthermore, in regard to other nations and economic blocs, such an arrangement is anticipated to strengthen member nations' economic relations and provide them more negotiating leverage.

Ciddikie and Khan (2014)5believed that the South Asian Free Trade Agreement (SAFTA) was an agreement signed during the 12th SAARC summit in Islamabad on January 6, 2004, and that it included India, Pakistan, Bangladesh, Bhutan, Sri Lanka, Afghanistan, Nepal, and the Maldives. It founded a free trade zone with 1.8 billion population. The SAARC's development as a regional trade grouping and economic union started with SAFTA.

To Examine India's foreign trade with the SAARC nations (Sri-Lanka, Bangladesh, Nepal, Pakistan, Bhutan, Maldives, Afghanistan).

Empirical Analysis

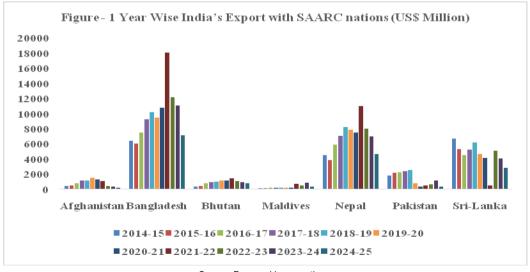

Export with Afghanistan, Bhutan, Maldives, was not much successful.

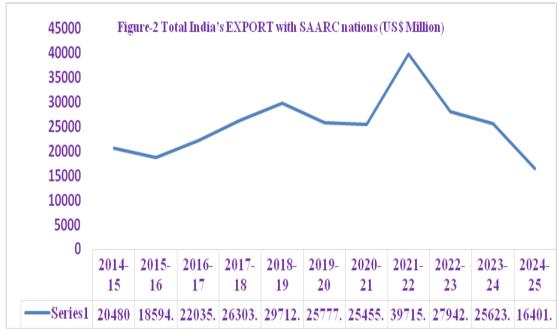
Export with Pakistan was almost on lower, due to Political tensions

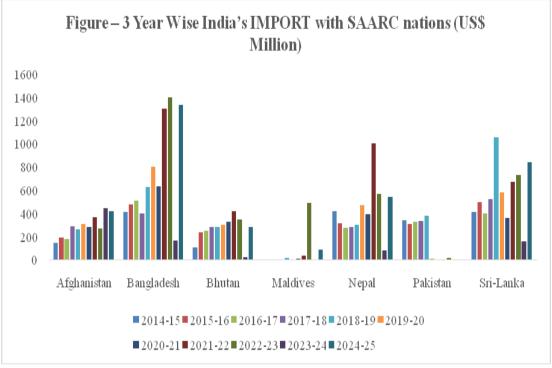

- It has also been observed that, India's trade with SAARC nation was highest in the year 2021-22, i.e. 39715.28 US\$ Million. While, in the year 2024-25, India's trade with SAARC nation was lowest ever in the decade with 16401.3 US\$ Million.

Conclusion

There was a tremendous trade took place before the pandemic. Due to various factors such as market size, demand pattern and political relations trading with the country such as Afghanistan, Bhutan, Maldives, and Pakistan remain very limited. India's Export with the selected SAARC nations such as Bangladesh, Nepal and Sri Lanka have increased gradually that shows overall growth in trade, and with other nations it is not that much good. It is found that in recent years, India has increased import and export with Bangladesh Nepal and Sir Lanka in terms of Value.
